ORDER

The Governor has been pleased to extend the benefit of FD No.1091-F(P2) dated 01/03/2024 only to those Supervisors, SHG&SE, who were in position as on 1st January, 2018 and were allowed the benefit of No. 1107-F(P2) dated 25/02/2016 vide FD UO No. Group P2/2017-2018/0923 dated 10/01/2018 subject to the condition that Rs.1,000/- per month as fixed T.A. won't be taken into account in computing yearly enhancement of the consolidated remuneration.

The undersigned is also directed to say that the remuneration of Supervisor, SHG&SE engaged on purely contractual basis is hereby enhanced w.e.f. 01.04.2024 as per following manner:-

Period of Engagement	Remuneration	Annual Enhancement
On initial Engagement	Rs.17,000/-	Rs.600/-
On completion of 5 years from initial engagement	Rs.21,000/-	Rs.700/-
On completion of 10 years from initial engagement	Rs.26,000/-	Rs.800/-
On completion of 15 years from initial engagement	Rs.32,000/-	Rs.1,000/-
On completion of 20 years from initial engagement	Rs.39,000/-	Rs.1,100/-

All other existing conditions of engagement shall remain unchanged.

At the time of giving annual enhancement/fixation to such contractual workers, all the conditions as laid down in the F.D.'S O.M. No.1091-F(P2) dated, 01.03.2024 should be strictly adhered to.

Over drawal if any, due to erroneous fixation will be recovered from the incumbent forthwith.

The Principal A.G.(A&E), WB and all concerned are being informed accordingly.
